- 2) Original Model PLANA 14261 and modification Model PLANA 14262 are alternatively identified as IDEA 16261 and IDEA 16262 and grey in colour;
- 3) Modification models IDEA 16261-B and IDEA16262-B are white in colour identified by suffix -B All 10A, incorporating supplementary clips to the contacts;
- 4) Modification models 14261SL and 14262SL are similar to approved Model PLANA 14261 except colour is grey and painted with silver;
- 5) Addition of Model EIKON 20262, 15A/250V, shuttered socket outlet in grey colour and for flush wall mount;
- 6) Models EIKON 20262.B and EIKON 20262.N are similar to Model EIKON 20262 except for face plate rim colour in white / silver;
- 7) Model ARKE 19262 is similar to Model EIKON 20262 except for change on panel size and terminal support colour;
